DESCRIPTION

On the vehicles affected by this bulletin retorque the monunting screws of the manual slide windows.

MATERIAL

No material is needed to perform the bulletin.

PROCEDURE



DANGER

Park vehicle safely, apply parking brake, stop engine. Prior to working on the vehicle, set the ignition switch to the OFF position and trip the main circuit breakers equipped with a trip button. On the Commuter type vehicles, set the battery master switch (master cut-out) to the OFF position.

Lock out & Tag out (LOTO) must be performed during set-up, maintenance or repair activities. Refer to your local procedure for detailed information regarding the control of hazardous energy.

1. Apply a manual torgue of 20 ft-lb to each of the nuts of the manual slide windows, image below;
