


This bulletin does not necessarily apply to all the above-mentioned vehicles, some vehicles may have been modified before delivery. The owners of the vehicles affected by this bulletin will be advised by a letter indicating the Vehicle Identification Number (VIN) of each vehicle concerned.

#### DESCRIPTION

On the vehicles affected by this bulletin, the equipment used to tighten the wheel lugs in a visit to one of our Service Center between November 2014 and June 2015, was found to be out of specification, possibly delivering a torque value inferior to the specified 450 to 500 ft-lb (610 to 680 Nm). Please verify and correct as necessary the wheel lug torque on the concerned vehicles, or bring the vehicle at a Prevost Service Center for verification at your earliest convenience.

#### PROCEDURE





1. Raise the vehicle by its jacking points.

2. With a properly calibrated torque wrench and appropriately sized open box socket, check the torque value of *the lug nuts on all vehicle wheels* following the sequence shown above. Correct as necessary.

Correct torque value for all wheels: 450 to 500 ft-lb (610 to 680 Nm).

Tightening should not be done immediately after prolonged braking or when wheel ends are hot.
