# DESCRIPTION

The type of fluid used and the frequency with which that fluid is changed can noticeably influence optimum performance and reliability of heavy-duty automatic transmissions. Allison Transmission Division of General Motors has designed extensive programs including specifications and tests to verify the quality of fluids and consequently can make specific fluid and filter change recommendations. Due to field studies, changes in emission requirements, vehicle design, and operating environments, Allison Transmission has realigned recommended fluid and filter change intervals to more closely match the operating environments heavy-duty automatic transmissions are found in today. Allison Transmission has also entered into a joint partnership with Castrol® Ltd. to offer a new option when selecting transmission fluid.

# TERMS AND CONDITIONS OF ALLISON TRANSMISSION EXTENDED TRANSMISSION COVERAGE (ETC)

**NOTE:** In order to comply with the terms and conditions of Allison Transmission extended transmission coverage (ETC), you must remove transmission fluid and use TranSynd oil. You have two (2) months after receiving this Maintenance Information, that is to say April and May of 2001 to perform this modification.

#### ETC ELIGIBILITY

Most Allison automatic transmissions purchased at retail for use in on-highway vehicle applications are eligible for coverage. ETC may be purchased only within 12 months after delivery of the vehicle to the first retail purchaser.

Use of TranSynd® or Test Engineering Specification 295 (TES 295) equivalent transmission fluid is a requirement for the full term of the Extended Transmission Coverage (ETC). The use of TranSynd or TES 295 equivalent transmission fluid is required for all transmission models, excluding off-highway transmission models.

TranSynd or TES 295 equivalent transmission fluid must be installed during the first initial transmission fluid change or one month following the ETC registration, whichever occurs later. Proof of transmission fluid maintenance may be required. Failure to comply with the use of TranSynd or TES 295 equivalent transmission fluid will result in termination of the ETC contract. Any repairs that occurred outside the standard warranty period will not be honored.

### ETC COVERAGES

ETC is available for one, two, or three years with unlimited mileage / hours for the transmission as purchased from Allison Transmission. Allison will pay for towing and 100% parts and labor for covered repairs during the ETC coverage period.

### AGREEMENT PERIOD

ETC coverage time is measured from the end of the standard warranty period.

## ETC PRICES

The suggested retail price is established for each transmission model / application combination for each of the three coverages available (one, two, or three years).
