DESCRIPTION

On vehicles equipped with an independent front suspension, the life span of one structural member is problematic and potentially limited. This structural member supports the left idler arm and bell crank. In order to eliminate all rupture possibilities, two bolted and welded brackets must be installed. You must make an appointment with the nearest PrevoSt service center in order to get these two brackets installed and also to proceed with vehicle realignment.
