DESCRIPTION

On vehicles affected by this recall, all 2½ lb fire extinguishers (p/n 901360) equipped with a straight plastic handle and vertical pull pin have to be replaced by fire extinguishers equipped with a metal handle and metal pull pin.

PROCEDURE

1. Locate all the existing 2½ lb fire extinguishers on the vehicle (Figure 1).

NOTE

All vehicles should have at least two fire extinguishers. There is one on the left side of the aisle and one on the right side of the aisle. Check the vehicle configuration for the exact amount of fire extinguishers.



2. Replace all existing $2\frac{1}{2}$ lb fire extinguishers with straight plastic handle and vertical pull pin (Figure 2) with the new $2\frac{1}{2}$ lb fire extinguishers with the metal handle and metal pull pin (Figure 3).



- 3. To avoid interference between the handle and the seat, orientate both new extinguisher handles down as shown on Figure 4.
- 4. Bulletin is complete for these vehicle models.



DESCRIPTION

On vehicles affected by this recall, all $2\frac{1}{2}$ lb fire extinguishers (p/n 901360) equipped with a straight plastic handle and vertical pull pin have to be replaced by fire extinguishers equipped with a metal handle and a metal pull pin.

PROCEDURE

 Locate all the existing 2½ lb fire extinguishers on the vehicle.

NOTES

All vehicles should have at least two fire extinguishers. Check the vehicle configuration for the exact number of fire extinguishers.

FIGURE 5 shows a typical installation when the vehicle is delivered to the converter partner. Location of the fire extinguishers might be different.

2. Replace all existing 2½ lb fire extinguishers with straight plastic handle and vertical pull pin (Figure 6) with the new 2½ lb fire extinguishers with the metal handle and metal pull pin (Figure 7).

- 3. To avoid interference between the metal handle of the first fire extinguisher and the cylinder of the second fire extinguisher, turn slightly and apply the same angle to both fire extinguishers (Figure 8).
- 4. Bulletin is complete for these vehicle models.



DESCRIPTION

On vehicles affected by this recall, the 5 lb fire extinguisher equipped with a plastic handle and vertical pull pin has to be replaced by a new fire extinguisher equipped with a metal handle and a metal pull pin.

MATERIAL

Order one kit per vehicle according to your country. Kits contain the following parts:

PROCEDURE

1. Locate the existing 5-lb fire extinguisher behind the driver's seat of the vehicle.

NOTE

Figure 9 shows the installation when the vehicle was delivered. Location of the fire extinguisher might be different.




- 2. Check the handle and pull pin on the existing fire extinguisher.
- 3. If the extinguisher is equipped with a plastic handle and vertical pull pin (Figure 10), move to step 4, otherwise the bulletin is complete.

NOTE

Figure 11 shows the location of the 10-digit date code on the side of the cylinder. Digits 5 through 9 represent the day and year.

All fire extinguishers with the date code XXXX29715X (October 24, 2015) or later have to be replaced.





- 4. Replace existing 5 lb fire extinguisher with the plastic handle and vertical pull pin (Figure 10) with the new 5 lb fire extinguisher with the metal handle and metal pull pin (Figure 12).
- 5. Bulletin is complete for this vehicle model.
