This bulletin does not necessarily apply to all the above-mentioned vehicles, some vehicles may have been modified before delivery. The owners of the vehicles affected by this bulletin will be advised by a letter indicating the Vehicle Identification Number (VIN) of each vehicle concerned.

DESCRIPTION

On the vehicles affected by this bulletin, an inspection of the exhaust gas diffuser is necessary. Refer to Part 1 of this bulletin for the inspection procedure.

If the inspection procedure reveals that the diffuser rain cap is not functioning properly, replace the diffuser assembly (see Part 2).

PART 1 - INSPECTION




DANGER

Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.

 While keeping the diffuser louvered grille fastened, check for proper functioning of the rain cap inside the diffuser housing, make sure that it <u>moves freely</u> and <u>seals</u> the exhaust pipe properly. If this is not the case, have the diffuser assembly replaced.

If the rain cap works properly then no additional inspection or repair is needed.




PART 2 - REPLACEMENT

Order the following parts:

Part No	Description	Qty
21603076	DIFFUSER ASSEMBLY	1
540067	CLAMP, HOLDING	1
5001684	NUT, CAP	10
502573	WASHER, FLAT	10

NOTE	
Material can be obtained through regular channels.	

- 1. Open Diesel Particulate Filter (DPF) compartment access door.
- 2. Unfasten drain pipe fitting from diffuser assembly.
- 3. Remove diffuser holding clamp located above diesel particulate filter.
- 4. Remove the current diffuser assembly. It may be necessary to remove the DPF compartment ventilation grille in order to remove the diffuser assembly.
- 5. Recover diffuser louvered grille and install on the new diffuser assembly using flat washers #502573 and new cap nuts #5001684.



NOTE


Always use anti-seize compound on diffuser fasteners.




CAUTION

To prevent damages caused by hot exhaust gases to the surrounding area, the diffuser grille must be flush with the roof surface or may not exceed the roof surface more than 1/4in (6mm).

- 6. Install new diffuser assembly but do not tighten holding clamp.
- 7. For proper angular position, make sure that the two edges shown are parallel with each other.



8. Using a straightedge, adjust the diffuser assembly level. The top surface of the tag fixed on the diffuser louvered grille must be flush with the <u>roof surface</u> or may exceed about 1/4in (6mm). Place the straightedge as shown on the image on the right.



- 9. Secure diffuser assembly using holding clamp #540067. Tighten clamps properly in order to prevent any movement of the diffuser assembly. An impact wrench is necessary.
- 10. Reconnect drain pipe to diffuser using pipe fitting.
- 11. Reinstall the DPF compartment ventilation grille. Apply Sika 221on the mounting screws.

PARTS / WASTE DISPOSAL

All replaced parts must be returned to Prevost according to the Return Shipping Instructions available on https://www.prevostcar.com/content/warranty-documents for full reimbursement. A copy of the warranty claim form must be enclosed with the shipment.

Discard waste according to applicable environmental regulations (Municipal/State[Prov.]/ Federal)
