DESCRIPTION

On vehicles affected by this recall, it is **absolutely necessary** to verify the screws fixing the passenger seats pedestal assembly to the floor rail system. There is a possibility that the manufactured screws were not of the proper quality and may break upon tightening or in use. If a "P" is present on the screw head, these must be replaced.


PROCEDURE



DANGER

Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.

1. Remove pedestal assembly end covers.



NOTE

Try re-using "Christmas Tree" type fasteners

2. Verify if "P" sign is present on cap screw head fixing pedestal assembly to the floor rail system.
3. If this is the case, these screws must be replaced with (500305) and torque tighten screw to 27 lb-ft.



CAUTION

This verification must be done with all passenger seats (qty 2 / seat)

4. Reinstall end covers and fix using "Christmas Tree" type fasteners (504619).

WARRANTY

This modification is covered by Prevost's normal warranty. We will reimburse you the parts and two hours (2.0) of labor upon receipt a completed A.F.A. form on which you must specify as per "Safety Recall 8-21". **You also have to fill the "Safety Recall Certification Sheet" provided with this bulletin and return it with your A.F.A. form to be reimbursed.**
