#### **APPLICATION**

### NOTICE TO SERVICE CENTERS

This Safety Recall does not necessarily apply to all the above-mentioned vehicles, some vehicles may have been modified before delivery. The owners of the vehicles affected by this recall will be advised by a letter indicating the Vehicle Identification Number (VIN) of each vehicle concerned.

#### DESCRIPTION

Vehicles equipped with Sure Power <u>model 52210</u> 100 Amp battery equalizer must have it replaced with Sure Power model 21100E00 100 Amp battery equalizer.

#### **DEFECT DESCRIPTION**

The affected battery equalizer contains a particular potting compound. According to information published by Sure Power Inc. "The specific potting compound used in the subject products for insulation was found to be capable of conducting electricity once exposed to significant thermal energy".

#### **FAILURE CONSEQUENCE**

The defect as determined by Sure Power may result in a vehicle fire.

### **MATERIAL**

Order kit **SR14-12** which includes the following part:

#### NOTE

Material can be obtained through regular channels.

#### **PROCEDURE**



## **DANGER**

Park vehicle on a level surface, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.



## **DANGER**

Wear proper safety clothing, gloves and glasses when working close to batteries.




FIGURE 1: BATTERY EQUALIZER INSIDE CONDENSER COMPARTMENT

- 1. Inside the condenser compartment, locate the Sure Power battery equalizer under the battery cover (figure 1).
- Inspect the battery equalizer. Confirm that it is a Sure Power, model 52210. This information is found
  on the decal affixed on the unit. No replacement is required if the battery equalizer manufacturer and
  model don't match these criterions.

- 3. Disconnect the battery banks ground cable from the chassis ground stud (figure 1).




FIGURE 2: SURE POWER 52210 BATTERY EQUALIZER

- 4. Carefully disconnect the ground cable **(0VE)** at the battery equalizer GND post first *(always disconnect the equalizer ground cable first and connect ground cable last)* by removing the nut (figure 2). Do not allow this cable to touch the other connections on the equalizer because all cables are connected to the batteries.

- 5. While proceeding one by one, carefully disconnect the 12-volt (12VA) and 24-volt (24VA) cables from the equalizer by removing the nut from the respective posts. Do not allow these cables to touch themselves. Apply insulating electrician tape on the cable terminals to prevent sparks or short circuits. Keep hardware for later use.
- 6. Remove the equalizer mounting screws (4 or 6 screws). Keep hardware (screws and washers) for later use.
- 7. Install the new equalizer, positioned similarly as the previous one using saved hardware.




FIGURE 3: NEW BATTERY EQUALIZER SURE POWER 21100E00 (PREVOST 563829)

- 8. Remove the terminal posts plastic cover (figure 3).
- 9. While proceeding one by one, connect the 12-volt **(12VA)** and 24-volt **(24VA)** cables to the equalizer 12V and 24V posts respectively, using the saved hardware (figure 3).

#### NOTE

When connecting cables to the equalizer posts (+24, +12, GND), do not exceed the specified torque of 110 lbf-in.

10. Connect the ground cable **(0VE)** to the battery equalizer GND post last.

- 11. Apply a coating of corrosion inhibitor material (e.g. dielectric grease) on equalizer posts, cable terminals and nuts.
- 12. Connect the battery banks ground cable to the chassis ground stud.

#### PARTS DISPOSITION

All replaced parts must be returned to Prevost according to the Return Shipping Instructions available on <a href="https://www.prevostcar.com">www.prevostcar.com</a> (under service / warranty section) for full reimbursement. A copy of the warranty claim form must be enclosed with the shipment.

#### WARRANTY


