This bulletin does not necessarily apply to all the above-mentioned vehicles, some vehicles may have been modified before delivery. The owners of the vehicles affected by this bulletin will be advised by a letter indicating the Vehicle Identification Number (VIN) of each vehicle concerned.

DESCRIPTION

On the vehicles affected by this bulletin and equipped with a Volvo engine, there is a possibility that the primary fuel filter be absent.

Engine starting during cold weather could be more difficult and an engine breakdown could occur if the water separation system was missing. All vehicles equipped with a Volvo engine but not equipped with "Davco Fuel Pro 382" filter are affected.

NOTE

Material can be obtained through regular channels.

PROCEDURE



DANGER

Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.

INSPECTION




FIGURE 1: INSTALLATION ON H3-45 COACHES




FIGURE 2: INSTALLATION ON X3-45 COACHES

1. Check if vehicle is equipped with "Davco Fuel Pro 382" filter. If Davco fuel filter is present, the procedure is done. There is nothing else to do (Refer to figures 1 and 2).

2. If the vehicle is not equipped with "Davco Fuel Pro 382" filter, perform step 2: INSTALLATION.

INSTALLATION




FIGURE 3: ENGINE ALTERNATOR SIDE – VERIFICATION OF TWO FILTERS

1. On engine alternator side, check if two fuel filters are present. If primary fuel filter is absent, one must be installed (Refer to figure 3).
2. In the case of vehicle 2PCH334988C711096 equipped with a primary fuel filter but without heating element, order parts #20879806 and 20771580.
3. All other vehicles equipped with a primary fuel filter c/w heating element, order parts #20879806 and 20875050.
4. Before the installation, remove the cap and fill the filter with clean fuel to prevent restarting problems.

NOTE

Keep the cap to send it with A.F.A. for full reimbursement.

5. Start the vehicle and allow running for a few minutes to remove any remaining air in the system.

WARRANTY

INSTALLATION

We will reimburse you the parts and **one hour (1.0) of labor** upon receipt of the cap and a completed A.F.A. form on which you must specify as per "Warranty Bulletin 09-24".
