
PROCEDURE




DANGER

Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.

- 1. In the engine compartment, inspect the lower part of the diffuser drain tube and make sure there is an excess length allowing proper seating of the clamp.
- 2. If it is not the case, unscrew the clamp to free the tube.







- 3. Add adapter #5011119 to the upper connexion.
- 4. Re-tighten lower clamp.
