On the vehicles affected by this bulletin, the "Vehicle Emission Control Information" label must be replaced.

CORRECTIVE MEASURES

To ensure conformity with EPA & CARB regulations, the decal must be replaced by a Prevost representative. Contact your nearest Prevost Service Center or Prevost service manager to schedule an appointment and have this modification performed at your earliest convenience. Have in hand your Vehicle Identification Number (VIN).

Since decals are vehicle specific, allow a few days for the order to reach your local Service Center.

PROCEDURE

 **DANGER**

Prior to working on the vehicle, park vehicle safely, apply parking brake and set the ignition switch to the ON position with the engine not running.

Do not attempt to repair or service this vehicle without having sufficient training, the correct service literature and the proper tools. Failure to follow this could make the vehicle unsafe and lead to serious personal injury or death.

1. Confirm the VIN on the new label matches the actual vehicle VIN.
2. Locate the “Vehicle Emission Control Information” label.

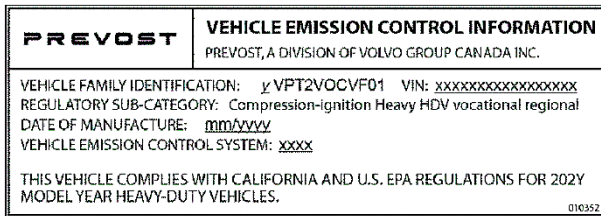


Figure 1: Vehicle Emission Control Information label sample

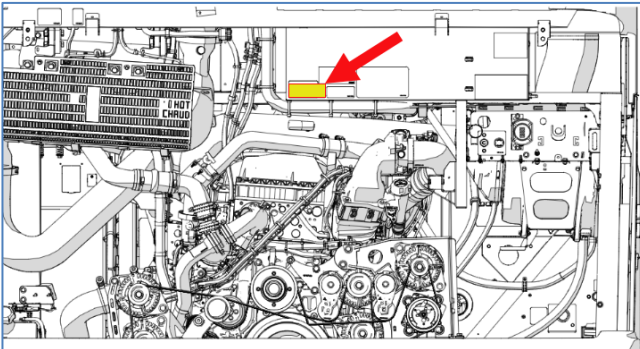


Figure 2: H3 SERIES

3. Use a plastic scraper and adhesive remover to gently remove the old “Vehicle Emission Control Information” label. Once done, **destroy the label.**

4. Carefully clean the decal area from all traces of dirt, road grime and old adhesive.
5. Affix the new “Vehicle Emission Control Information” label at the same location.

Do not install the new label over the old one

NOTE

A second “Vehicle Emission Control Information” label is provided as spare part in case the installation of the first one fails due to breakage, poor adhesion, etc.

If the spare label is not used, it must not be given nor kept and must be destroyed.

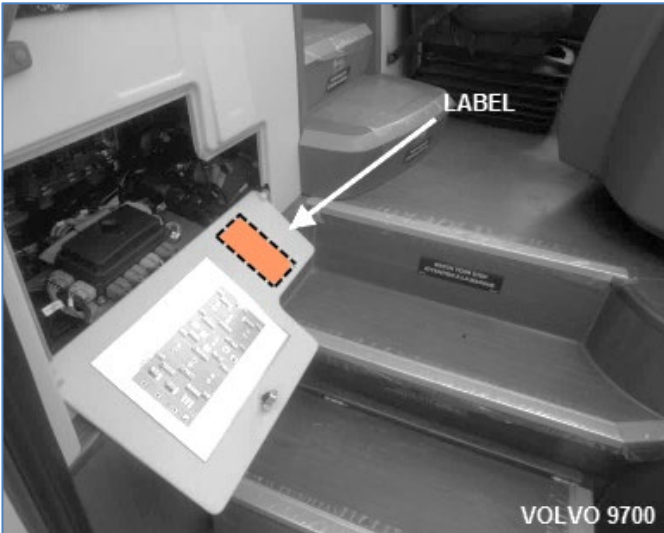


Figure 8: VOLVO 9700

6. Affix a campaign completion label p/n 85152363 (Figure 5) as shown on Figure 6-Figure 8.

7. On the campaign completion label, signify that the campaign has been completed. Use a permanent type of marker/sharpened pencil to write:
 - a. the recall number i.e., EC0026
 - b. the completion date (MM/DD/YYYY)
 - c. the branch/service center code.

8. A Certificate of Emissions Recall Completion is also provided in the kit. Fill in the appropriate information and give the certificate to the customer/owner of the vehicle. An image of the certificate is included at the end of this document should the provided certificate be damaged. **Preferably, use the one included in the kit.**
