DESCRIPTION

On the vehicles affected by this bulletin, changing of VECU (Vehicle Electronic Control Unit) parameters is necessary.


This update must be carried out by qualified technicians. Make an appointment with your nearest Prevost Service Center.

ELECTRIC AIR DRYER CUT-OFF PRESSURE & DESICCANT REGENERATION FACTOR


This update involves all **OBD13 & GHG14** vehicles in service (refer to Application table for involved vehicles range).

This update will reduce air dryer cut-off pressure from 144 psi to 140 psi and extend desiccant regeneration time, thus preventing presence of water in the accessory tank.

<p>Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.</p>

1. Connect Premium Tech Tool (PTT) to the vehicle diagnostics connector (OBD). Connect the PC to a functional LAN or modem connection and a 120 Volt AC source.
2. Turn the ignition switch "ON".
3. Once the vehicle has been identified and selected, perform Campaign S6991.
