### APPLICATION

## DESCRIPTION

On the above-mentioned vehicles, it is necessary to add a 3-amp fuse on two lamps located in the driver's section. This modification will improve the electrical reliability of the coach.

# MATERIAL

Select the group of your vehicle and order the corresponding material.

Group 1: Vehicles without a Gooseneck type lamp on the driver's left-hand control panel.

Group 2: Vehicles with a Gooseneck type lamp.

# PROCEDURE

**Warning:** Park vehicle safely, apply parking brake, stop engine and set battery master switch(es) to the OFF position prior to working on the vehicle.

## PART A: THIS PART APPLIES TO GROUP 1 AND 2 VEHICLES.

Addition of a fuse to the lamp located above the bin in the driver's section.




Figure 1: Typical location of the lamp, in the driver's section.

- 1. Locate the lamp (figure 1).
- 2. Open the front service compartment.
- 3. Identify and cut lamp wire #83.
- 4. Cut fuseholder wire, skin ends. Select the proper spring for #560893 fuse. Remove remaining springs, insert #560893 fuse and reassemble.
- 5. Twist wires and cover with a shrinkable tubing. Heat.

### PART B: THIS PART APPLIES TO VEHICLES OF GROUP 2 ONLY.

- 1. Open the front service compartment. Cut the 12 V power supply lead of the "Gooseneck" lamp.
- 2. Cut fuseholder wire, skin ends. Select the proper spring for #560893 fuse. Remove remaining springs, insert #560893 fuse and reassemble.
- 3. Twist wires and cover with a shrinkable tubing. Heat.

*Note:* Refer to the wiring diagram enclosed to see the final aspect of the modifications.

# WARRANTY
