Engine coolant: SHELL ROTELLA ELC NF pre-diluted 50/50 (Extended Life Coolant, Nitrite

Free)

Color: Red

NOTE

The color of the cooling liquids is only an added dye. Color does not represent a chemical incompatibility. So cooling liquids of different colors can be mixed.

COMPATIBILITY

Meets Volvo GTT requirements. Therefore, use this new coolant for Volvo D13 engine¹.

COMPATIBILITY WITH OTHER COOLANTS

Shell ROTELLA ELC NF Pre-diluted 50/50 is miscible and compatible with other engine coolants (antifreeze).

Dilution/mixing with non-equivalent coolants will reduce or eliminate the extended life properties. Therefore, do not mix this new cooling liquid with more than 20% of non-ELC coolant.
